AWARD

The winner will receive \$10,000 CAD and be recognized at CFA Society Toronto's Annual Awards Reception. The winner will also be acknowledged in *The Analyst* and on social media channels.

ELIGIBILITY

- Open to global researchers conducting research related to Canadian capital markets including both academics (e.g., professors and students) and practitioners (multiple authors per paper permitted)
- Papers that have won awards with other organizations will not be considered.
- Papers submitted for consideration must not have been published, accepted for publication or have received extensive press coverage.

EVALUATION CRITERIA

Submissions will be judged on the potential contribution of their applied research to topics of interest related to Canadian capital markets. Areas of research interest include any aspect of investment management, such as portfolio management, asset valuation, risk management, compliance and performance evaluation. Investment fields include traditional and alternative investments, as well as all asset classes and investment vehicles (e.g., fixed income, equities, derivatives, etc.). Research papers are judged on relevance, importance and the degree to which their research has an impact on practitioner's behavior.
