Investment fields include traditional and alternative investments, as well as all asset classes and investment vehicles (e.g., fixed income, equities, derivatives, etc.). Research papers are judged on relevance, importance and the degree to which their research has an impact on practitioner's behavior. Papers that have been published or accepted for publication, simultaneously submitted for awards with other organizations, or received extensive media coverage will **not** be considered.
